Tacoma Public Schools – Lisa Nolan

- In November, school board voted to promote the motion to extend levies and put them back on the ballot.
 - Released the mantra of "Every Student. Every Day."
 - Feb 13 ballot
 - Prop 1: funding day to day operations not funded by the state
 - includes special education support, teachers, liaisons, nurses, and more
 - expanded preschool programs, early learning sites
 - art programs, musics, athletics, expanded middle and elementary sports programs, educational material including textbooks
 - support safety and security, instruction, investigations of harassment and bullying, upkeep of schools and grounds – students learn better when barriers to safety are removed
 - Prop 2: replacement levy for technology, expand access to technology equitably in all neighborhood schools
 - Technology is an ever changing vessel, duty to be responsive to that.
 - Technology doesn't take the place of an outstanding educator and the relationship with teachers, but it can enhance the experience and promotes/supports the home access center, so families can check grades and performance online.

Pierce Transit – Penny Grellier

• If you utilize the Tacoma Dome Station, note that in Feb, that facility will start mid-life maintenance. Finally have the budget to spruce it up, get it in good form. It is going to be a year's worth of work, as it

will happen in stages. Segments of 200 parking spaces at a time closed of for renovation. Adjacent parking areas will be made available.

- Question from Tony: parking is free now yes? And will there be a fee afterward?
 - Free now, has been studied, no activity yet. Gets crowded as there are some using it that aren't using transit.
- Question from Eric: will the extra parking spaces be free? Most of the lots are paid around there.
 - One near the Tacoma Dome has a monthly fee, a lettered lot, may have a fee. Check the website for locations.
- Question from audience: will they open the 2-3hr parking at the Tacoma Dome that nobody uses?
 - Not sure about those spaces. We do parking studies in different park and ride lots.
- Question from Cary: Monday through Friday or weekends?
 - Weekends too most likely for speedy renovation
 - Question from Tony: what about security?
 - Security guards on site

Ideas from Audience for comments and suggestions for 2018

- City Council has closed up their city forum. There are 3 essential problem spots in the city that are coalescing. The Dreamers are being tossed under the bus. The Deportation Center. The City, the Port, and PFC.
 - 1. Want financial security for the city by way of liability insurance for the LNG tank to be nearby the deportation center, both of which are moral affronts. The Port and City should insure against life-threatening accidents.
 - 2. Suzanne recap: concern over how immigrants in our City are affected, since Tacoma wants to be a sanctuary city. Environmental security. Immigrant concern. Communication to the City by way of the City Council since the City Council forum is closed to citizens.
- 2. Neighborhood Council, Safe St, Next Door, different apps. People are putting in concerns in a random, disjointed way. Is there something that could be developed to unite different inputs? Right now, you can call non-emergency for something actually happening. Want to help the police workloads. Police not showing up to Safe St meetings or to neighborhood council meeting as well. What it if there is a way to communicate between groups.
 - 1. Tony comment: call it in, to non-emergency and to emergency, since the emergency line records it.
 - 2. Daniel: 2nd Monday of the month, Police Advisory Committee
 - 3. Suzanne recap: if the Police doesn't come to us? We come out to them, at the Citizens Police Advisory Boards.
 - 4. Kristin: but then, if we send someone there, what do we say? The question is how to consolidate the data.
 - 5. Janis: work with Safe St, not reinvent the wheel.
- 3. Resident who moved out 1.5 years ago, lives on 64th between Yakima and Pacific. The crosswalk at Stewart Middle school is not lit at 52nd and Pacific. The orange lights don't brighten things up. Other parts of the city get work, but the South End area seems to need more work.
 - 1. Eric: recommends calling 311
 - 2. 64th from Pacific to McKinley one bag road.
 - 3. Crosswalks in general are not lit. Yakima is not lit 4 lane road with 35mi limit.
 - 1. 80% of lights are being replaced with LEDs, starting in South End
- 4. Homelessness Pacific and 72^{nd.} A lot of intoxication all along Pacific. I saw flags go up on the flag posts for Pacific Avenue business district, but have seen more businesses close than open. Need more restaurants. Human trafficking ring taken out. Motels have been shut down.
- 5. Prostitution.
- 6. Master Transportation Plan has nothing for South End. Overflow from Pacific is going through the neighborhoods. The buses on Pacific back up traffic, so they go through the neighborhoods.
 - 1. Comment from Penny: doing a study for high capacity non-stop transit to help reduce the stop and start.

- 7. In December we have 150 open code enforcement cases, where north end has 21. Down to 2 police Community Liaison Officers. Down to 9 narcotics officers.
 - 1. Kristin summary: look at resources distributed throughout the City and get more allocated to the South End.
 - 2. Eric: TPD has 19 vacancies.
- 8. See more community education about dangers of the LNG.
- 9. Sidewalks are terrible. Spotty, and where they are, they're not in good shape. Kids walking in the streets. Big safety concern.
- 10. Janis: in this city, the City Manager has the power. We want to highlight to the City Manager Rep that there are outstanding issues. The Rep to the meeting changes, but nothing seems to change. Please make sure to report up to your boss what the citizen's, not just the neighborhood council's, concerns are.
 - 1. Chris Bell: Absolutely. Here to gather concerns and report. There are a lot of concerns that have stuff in the works, but the effect hasn't been felt yet.
 - 2. Chris Beale: just in 3rd week of City Council. Will be focusing on these issues this year. Nuisance laws and code enforcement. Pacific Ave. We could make the citizen GIS map, a crime map that residents can put pins in. District 5 includes 3 neighborhoods. Trying to be here as often as possible.
 - 1. Suzanne: thank you for showing up.
- 11. Suzanne: representation from SENCo going to the different agencies. Advocacy for our students. Playgrounds open to kids, not having chains closing them on weekends.
- 12. Advocate City transparency: city website says 4 CLOs, South End only has 2. Tacoma Police Dept needs to have accurate listings so residents can contact for community safety purposes.
- 13. Janis: TV Tacoma's Neighborhood Moments program. Use the television to get our point across, to showcase our neighborhood. City Line is a new program where we can highlight and talk about what's going on.
- 14. Marketing efforts and council outreach.
 - 1. Advocacy.
 - 2. "Come and Go" come to us, we will go to you
- 15. Athena reviewed bylaws for Neighborhood Council purpose
 - 1. Earl: to fulfill our mission, we can send letters but we cannot address the City Council at their meetings speaking on behalf of the Neighborhood Council. We can comment as individuals.
 - 1. Chris Beale: if there is a topic, email him and he can help get it on the agenda.
- 16. Geographic Information System map that individuals have access to, with layers for police business, education, with time element, city would be able to see at a glance.

- 17. Suzanne: monthly report of incidents/location concerns, maybe more formal than a newsletter, possibly built off the minutes.
- 18. Audience: do you have members go to other neighborhood council meetings?
 - 1. No, but the Community Council of Tacoma (CCOT) meets every 4th Thursday at Room 16 in the north annex, 6pm, 737 Market St, Tacoma, WA 98402. Has representatives of all the neighborhood councils. Audience members encouraged.
- 19. Athena: updating our agenda to close with a thanking the audience and challenging to tell 2 people about the meeting.
- 20. Now have survey monkey, twitter, instagram, youtube share the handles so folks can tag
- 21. Janis: target military service members, veterans, and their families
- 22. Tony:
 - 1. reach out to businesses to get meeting notifications up on their electronic message boards.
 - 2. Seek input for park 61st and Sheridan, Ailling Park
 - 3. take photos of places and events
 - 4. seek grants for projects
 - 5. Yard of the Month may help with code enforcement as people take pride in building their houses up. Houses get nominated, board members check them out, do 1st, 2nd 3rd place.

 - 2. Audience: Zoning issue a lot of multi-use
 - 1. Recommend positive feedback for Linda, the new manager at the McDonalds of 72nd and Pacific, has done a great job.
 - 2. Recommend positive feedback for Troy Grey at Fred Meyer. Corporate has agreed to look at the area outside.
- 24. Chris Beale: Recommend make a table, define what success looks like, short term goal / long term goal, form groups to do it.
